## **Methods for CLD Programs**

TABLE 3: Description of Training Methods Deployed by Leadership Development Programs

TRAINING METHOD	TRAINING METHOD EXAMPLES & DESCRIPTIONS
Classroom-Style/Workshops	Lectures, simulations, worksheets, games, and other traditional teaching methods.
Field Trips & Volunteering	Exposure to real-life examples of issues, their related impacts, and/or effective and functional solutions; sometimes incorporates learning-by-doing in a volunteer capacity to gain entry-level expertise in specific topics.
Project-Based Learning	A culminating project to apply learned skills, similar to a capstone project or academic thesis.
Job-Based Training	Paid, on-the-job training and certifications to advance individuals beyond entry-level experiences.
Hands-On Civic Engagement	Participation in the legislative process, including calling/meeting with elected officials, delivering testimony, canvassing, etc.
Summits	Conference-style learning that allows individuals to network outside of their training program with other program alumni or community members; provides a venue to showcase their own learning.
Local Expert Panels	Panels in which local leaders and experts share their own knowledge and experience in a discussion-based forum.
Mentoring/One-on-One Coaching	Matching trainees with issue-area experts for individual and customized attention to trainees' growth.
Alumni Networks	Utilizing program alumni as real-life examples of success, inspiration, and accessible storytelling.





## RESULTS Knowledge/Perceptions on Climate Change

- How much do you know about CC? 50% little or nothing
- Is climate changing in OV? 63% Yes, 28% Not Sure, 9% No
- If yes, what risks are there in OV?
  - Major Themes Identified:
    - Flooding
    - More Extreme Weather
    - Illness/Flu/Fever
- How likely is a disaster here? 71% somewhat to very likely
- How severe would the impact be to you? 75% somewhat to very severe







- Created in 2020 during planning period-COVID
- Trained 12 residents on climate change to engage and advocate about health impacts
- Compensation through stipends
- Codesign a climate justice survey
- Educate their network
- Program developed organically





## Testifying on HB4556

87R1177 JXC-F

H.B. No. 4556

#### A BILL TO BE ENTITLED AN ACT

relating to energy efficiency goals for electric utilities.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 39.905, Utilities Code, is amended by adding Subsections (a-1) and (a-2) to read as follows:

(a-1) In addition to meeting the demand goals provided by Subsection (a), each electric utility shall also meet an annual energy savings goal of:

(1) one-fourth of one percent annual energy savings in the 2022 calendar year;

(2) one-half of one percent annual energy savings in the 2023 calendar year;


(3) three-fourths of one percent annual energy savings in the 2024 calendar year; and

(4) one percent annual energy savings beginning with the 2025 calendar year.

(a-2) The commission by rule shall provide a method to establish each utility's annual savings goal under Subsection (a-1). The method must be based on the existing and expected usage of electricity delivered in a utility's service area that is required to pay the annual energy efficiency cost recovery fee. In adopting rules, the commission may provide for cost caps for the implementation of Subsection (a-1) and provide good cause exceptions for a utility that is unable to meet the goal in a cost-effective manner.

SECTION 2. The Public Utility Commission of Texas shall adopt rules to implement the changes made by this Act to Section 39.905, Utilities Code, not later than December 31, 2021.

SECTION 3. This Act takes effect September 1, 2021.

## CEER's Theory of Change

- > CEER recognize residents as experts
- Communities at the frontlines of climate change have the solutions to the problems
- Community voices need to be at the decision-making table to promote equity and resilience



### Creating Structure: Leadership Ladder Model

#### **Volunteers**

Shares the same values as the organization or community. Joins and contributes at events.

#### **Members**

Has a specific role in org and/or event. Joins org meetings, Recruits volunteers, and receives training

#### Leaders

Leads Events or org. meetings, gives trainings, (Train the trainers)

#### **Team Leaders**

Supervises and coaches Leaders

#### **Community Climate Ambassadors**

As one of CEER's Climate Justice Campaign Community Climate Ambassadors, I will be tasked with meaningfully engaging my neighbors, friends, and existing networks. I am eager to spark authentic conversations between people on how they think and talk about climate change. Topics include but are not limited to: energy, transportation, flooding, extreme heat, pollution, food, and access to nature. I will advocate for better health and safety outcomes as they relate to climate and environmental issues.

#### To advance our work forward, Community Climate Ambassadors

#### ill be financially compensated for the following tasks:

- •Attending weekly Climate Ambassador Team Meetings on Monday evenings at 6:00PM CST either via Zoom or in-person.
- •Participating in workshops and trainings to learn more about climate-related issues and contribute my thoughts to the conversations.
- •Collaborating with CEER's full-time staff, partners, and members to coordinate the campaign into action.
- •Educating the community on climate issues and interviewing people to better understand their challenges and opportunities.
- •Inviting your network to participate in monthly Northeast Community Meetings on the 3<sup>rd</sup> Tuesday of the month as well as other public community events hosted by CEER.
- •Identifying actions that the community wants to take together for a better future so that no communities are left behind and are protected from climate change.
- •Contributing historical knowledge and/or lived experience to provide an accurate representation of Houston's northeast community
- •Engaging a diverse set of residents and multiple generations of people to support CEER's Climate Justice Campaign

#### How much will Community Climate Ambassadors be paid?

This is a contract position expected to last at least until May 2024. Ambassadors will be paid a stipend each month for 20 hours per month @ \$18.00/hour. If you are unable to meet the requirements of this contract position on an ongoing basis, CEER may terminate your position at-will.

## Elevator Speech (10 min)

An elevator speech is a brief opportunity (one minute or less) to answer the questions: "What do you do and why should I care?"

The goal is to plant a seed of curiosity so as the elevator doors (real or metaphorical) open, the listener says, "Tell me more."







Everyone takes about 1 minute to share their Climate Justice Campaign or Climate Ambassador elevator speech!




## Spheres of Influence

Our ability to make change is connected to how we have influence. Understanding the layers of our connections helps us to make a greater change and impact.





Spectrum of Allies



- We often have the wrong idea that we need to win everyone to our side, or that we need to change the fossil fuel industry or the people actively fighting against us.
- This wrong idea invites despair or feeling defeated
- When we bring an optimistic attitude, instead of one of despair, to the work, it is a lot easier to get people on board.



## Preparing the Frontlines for a Climate Future through Holistic Weatherization



We are working on a home retrofit process that significantly increases eligibility of low-income residents participating in the weatherization program.



## 2023 CEER Navigator Program

- > Collaborative
- Co-Production Model HARC + CEER
- ➤ Community Navigator Model CEER
- Recruit and train 10 residents as Community Navigators
- Co-design intake process with a focus on program access and outreach
- Organize community events in person and invite residents to explain intake process
- Marketing plan to recruit targeted participants



## **CEER Community Navigators**

Navigators will work as a liaison for residents to actively participate in the design, planning and implementation of the project.





## **Community Navigators**

Will be trained on home retrofitting/weatherization, deferred maintenance, energy burden, and how making our homes climate ready connects with the bigger picture of solutions to climate change.
